**Re: Ratings of PT Bank QNB Indonesia Tbk**

**PT Fitch Ratings Indonesia** (“Fitch”) has affirmed the following ratings:

- National Long-Term Rating of '**AAA(idn)/Outlook Stable**
- National Senior Unsecured Rating of '**AAA(idn)**'
- National Long-Term Rating of '**AAA(idn)**' of the Shelf Registration Bond Programme I Phase I Bank QNB Indonesia Tbk 2019 amounted to IDR100 billion with a maturity of 3 years
- National Long-Term Rating of '**AAA(idn)**' of the Shelf Registration Bond Programme I Phase III Bank QNB Indonesia Tbk 2020 amounted to IDR448 billion with a maturity of 1 year

In issuing and maintaining its ratings, Fitch relies on factual information it receives from issuers and underwriters and from other sources Fitch believes to be credible.
